

# Liwayway Group's CARLOS CHAN is MAP Management Man of the Year 2021



The MANAGEMENT ASSOCIATION OF THE PHILIPPINES (MAP) announced recently the selection of **Amb. CARLOS CHAN**, Chair of Liwayway Group, as the recipient of the "*MAP Management Man of the Year 2021*" award.

The "MAP Management Man of the Year" is an award that the MAP confers on individuals in business or government, whether a member of the MAP or not, who have attained unquestioned distinction in the practice of management, and have made valuable contributions to the progress of the country and in re-shaping national values. 

# "MAPping th Future" Column in INQUIRER

"All-risk environment"

Let's talk about our risk environment. I've been harping on this because my sense is that we're not engaged in a whole-of-nation effort. Would it be correct to say that there's no palpable systematic whole-of-society nor whole-of-government integrated initiative to mitigate and manage risk? I believe we're still very much on our own, left to fend for ourselves.

I don't intend to map out our risk universe. I'll just pick a few major ones for discussion: *human security, ecological security, national security and cultural risks*. Each of those risks are in themselves complex and interrelated.

- Human security risks: education, energy, employment, financial, health, shelter, food, public safety, mobility, information, connectivity.
- Ecological security risks: climate change impacts, i.e., rising sea levels, rising temperatures, extreme weather; destruction of forests, watersheds, mangroves and coral reefs; mindless pollution of waterways and oceans.
- National security risks: inability to modernize the uniformed forces; rising external and internal threats maritime intrusions, infiltration of society and government, subversion, armed rebellion and terrorism.
- Cultural risks: loss of moral moorings, erosion of ethical standards, unable to discern wrong from right; attitudinal and behavioral abnormalities resulting in systematic corruption, social injustice; unequal distribution of wealth and widespread poverty; inferior standards of performance.

I consider those as inter-generational risks that are not being given the required attention that they deserve. The consequences of neglect keep piling from one

administration to the next, and from generation to generation. We must question the degree of our situational awareness, aptitude and skill for risk management. Do we have the right people in place manning their posts, collaborating with each other to assess and mitigate risk? Comparisons are odious but I envy the state of governance and civic consciousness of, say, Singapore and South Korea.

This brings to the fore *political risk*, as in gutter politics, that stinks from all the syndicated and individual wrongs committed daily though the march of time by those who hold dominion over us. Election after election, we go through the pretense of democracy choosing from a menu of mostly unworthy "winnable" choices offered by political syndicates whose vested interests come before the nation's good. Crime and corruption abound in such an environment, where those in power build on the malfeasance and misfeasance of previous occupants.

A world war is being waged by a virus against mankind and remains in control two years after it was detected. It remains in control wrecking economies, shattering lives and upending the way we were which wasn't exactly commendable. From our end, the quality of risk and crisis management leave much to be desired – it's disorganized, haphazard, reactionary and unintelligent. While some are burning the midnight candle to save lives, others are low-life shameless opportunists allegedly producing tons of illicit wealth along the way.

With sea levels rising, extreme weather and rising temperatures ravaging food supply, poor farmers and fishermen are being driven deeper into poverty. There's much to be done to rezone our land mass for natural habitats, reposition human settlements and restructure economic endeavors. A national blueprint backed by forward-looking policies and plans is necessary to serve as the government's North Star. For example, urban vertical farming, fresh water replenishment, renewable energy and wireless technology. Is the government working on it?

From the looks of it, the US and its allies are headed toward a kinetic clash with China and its allies. China keeps raising the ante in the Taiwan Straits, East and South China Seas. They won't budge on their core interest. Should China attack Taiwan, Northern Luzon will be a tempting target. Should China and the US clash in the Spratlys, Palawan and Panatag will be tempting targets. The government must accelerate the AFP's modernization by tapping the private sector to help it find better ways and means to fund it. Is it?

The fall of Afghanistan to the Taliban has rekindled fears that it might be used again as a springboard for terrorism around the world. The Taliban has known ties with Al Qaeda which maintains a presence in Southeast Asia. That was my headache as SILG of PFVR. Other black flag groups have established a presence there and in nearby Pakistan, like ISIS. A resurgence is foreseen by global counter-terror experts unless the global community unites to share intelligence, conduct joint operations and extend mutual legal assistance.

But the worst enemy of the Filipino is the Filipino himself – his "kultura" or "ugali", his juvenile attitudes and individualistic behavior skewed toward self-interest, self-promotion and self-gratification. No unity, no shared effort, no sense of nationhood. "Kanya-kanya" prevents us from converting our potentials into powerhouse realities.

It's the mother of all risks that we've failed to attend to. We either don't want to, don't know how or don't know why.

Without zero tolerance for wrongdoing, powerful predators will continue to lord it over our weak society. When we have the wrong people manning our government and social institutions, when we elect the wrong people, when we don't do anything to deny them the opening, time and space to rule us, when we do nothing to push them back and extract punishment as well as compensation for the harm they've done, we will continue to be where we are right now. If we want a strong upright Philippines, we need to first become strong upright Filipinos.

We're inside a rotten box that needs to be trashed. Wouldn't that be the best risk mitigation measure of all? After all the squandered years, it's come to this where we have no other option but to change the rotten box if we want to save our future. Staying in it and working our way through it is no longer viable. National survival depends on changing our "kultura" and adopting a mindset that places good governance, civic consciousness and the common good ahead of all else. That's how we can best tackle an all-risk environment.

"Constitutional Basis for Social Responsibility of Corporations Vested with Public Interest"

We come to the root of where all great debates in the Philippines seem to start or end up with — the constitutional basis of *Corporate Social Responsibility (CSR)*, as the basis for upholding the Stakeholder Theory for publicly-held companies and all other corporations vested with public interest.

Although the constitutionally guaranteed principles of private ownership and freemarket system are now beyond argument, our Constitution has, in unmistakable terms, decreed the *"social function"* of private property and economic enterprises, even when held or pursued through corporate medium, thus: SEC. 6. The use of property bears a social function, and all economic agents shall contribute to the common good. Individuals and private groups, including corporations, cooperatives, and similar collective organizations, shall have the right to own, establish, and operate economic enterprises, subject to the duty of the State to promote distributive justice and to intervene when the common good so demands.

Sections 9 and 10, Article II of the 1987 Constitution declare that society should care first and foremost for its masses, rather than emphasizing the "individualistic" rights to property and livelihood, thus:

SEC. 9. The State shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all.

SEC. 10. The State shall promote social justice in all phases of national development.

In constitutional language, we as a nation declare that, above all else, equitable distribution of wealth and opportunities should be the main goals of society, and all activities, resources and equity shall be deployed to achieve such ends; that economic progress, although important, when it benefits only the few would be an unwanted boon.

The doctrine of the "social function of Philippine corporations" has been upheld and applied by the Supreme Court in *Chamber of Real Estate and Builders Association, Inc. v. Romulo*, where the main issue that had to be resolved was the lawfulness and constitutionality of the minimum corporate income tax (MCIT) imposed upon all corporations which did not report taxable income after the initial three succeeding taxable years of operations.

The Court summarized the technical aspect of the MCIT under the 1997 National Internal Revenue Code, thus: "Under the MCIT (minimum corporate income tax) scheme, a corporation, beginning on its fourth year of operation, is assessed an MCIT of 2% of its gross income when such MCIT is greater than the normal corporate income tax imposed under Section 27(A) of the NIRC. If the regular income tax is higher than the MCIT, the corporation does not pay the MCIT. Any excess of the MCIT over the normal tax shall be carried forward and credited against the normal income tax for the three immediately succeeding taxable years."

The Court noted that "The MCIT on domestic corporations is a new concept introduced by RA 8424 to the Philippine taxation system. It came about as a result of the perceived inadequacy of the self-assessment system in capturing the true income of corporations. It was devised as a relatively simple and effective revenue-raising instrument compared to the normal income tax which is more difficult to control and enforce. It is a means to ensure that everyone will make some minimum contribution to the support of public sector."

In justifying the constitutionality of the tax imposition, the Court in Chamber of Real Estate, employed a CSR principle that every corporation, even though operated primarily for profits, enjoys the protection granted by the State, and therefore is bound

to assume certain social responsibilities, thus: "Domestic corporations owe their corporate existence and their privilege to do business to the government. They also benefit from the efforts of the government to improve the financial market and to ensure a favorable business climate. It is therefore fair for the government to require them to make a reasonable contribution to the public expenses."

In fact, even the for-profit nature of private corporations was employed as the rationale for imposition of the MCIT, thus: The Court added: "The primary purpose of any legitimate business is to earn a profit. Continued and repeated losses after operations of a corporation or consistent reports of minimal net income render its financial statements and its tax payments suspect. For sure, certain tax avoidance schemes resorted to by corporations are allowed in our jurisdiction. The MCIT serves to put a cap on such tax shelters. As a tax on gross income, it prevents tax evasion and minimizes tax avoidance schemes achieved through sophisticated and artful manipulations of deductions and other strategems (sic). Since the tax base was broader, the tax rate was lower."

In particular, on the argument that the MCIT is "unconstitutional because it is highly oppressive, arbitrary and confiscatory which amounts to deprivation of property without due process of law," the Court employed not only the principle of taxes being the lifeblood of government, but also its duty to promote the common good, as the bases for upholding the lawfulness of the imposition, thus: "Taxes are the lifeblood of the government. Without taxes, the government can neither exist nor endure. The exercise of taxing power derives its source from the very existence of the State whose social contract with its citizens obliges it to promote public interest and the common good."

We may therefore conclude with the thought that, in the exercise of its police power and the discharge of its duty to promote the common good, the State, through its agencies, and the judicial system, shall continue to promote and enhance the social function of private property, of the CSR of private corporations, and of everexpanding and at the same clarifying the stakeholder theory in our jurisdiction.

There can therefore be little argument against the proposition that since private property and economic enterprise, which includes expressly that found in the corporate medium, is constitutionally endowed with "social function," then the State may, through its various agencies, mandate a system of corporate governance that shall hold corporations, their Board of Directors and Management accountable to, and owing fiduciary duties, to stakeholders other than just the shareholders.



# 1. "Savoring success: 'Snacks King' Carlos Chan named MAP's Management Man of the Year" Bilyonaryo October 12, 2021

Liwayway Marketing Corporation (LMC) chairman Carlos Chan, who founded the Oishi brand of snacks, has been chosen as the "Management Man of the Year" by the Management Association of the Philippines (MAP).

In a statement, MAP lauded Chan for his "unquestioned distinction in the practice of management" and valuable contributions to economic development of the Philippines.

The organization also recognized the Filipino-Chinese tycoon's "business acumen and management qualities," which helped transform a local cornstarch repacking business into a global snack brand.

Chan joins the ranks of other businessmen named as MAP's "Management Man of the Year", such as the late Washington Sycip, Jaime Zobel de Ayala and sons Jaime Augusto and Fernando Zobel de Ayala, and former central bank Governor Amando Tetangco.

LMC has at least 15 factories in China and five factories in the Philippines. Chan, the country's special envoy to China, was named an honorary citizen of Shanghai in 2005.
